THE FOUNDATION ESTABLISHED THE CIF DURING THE YEAR ENDED MARCH 31, 2021. THESE FUNDS ARE NOT CONSIDERED A PART OF THE LONG-TERM ENDOWMENT. THE PURPOSE OF THE CIF IS TO SUPPORT INVESTMENT IN MISSION RELATED INITIATIVES AND PROGRAMS AT THE DISCRETION OF THE PRESIDENT AND WITH THE APPROVAL OF

THE BOARD. THE CIF HAS ITS OWN INVESTMENT ALLOCATION POLICY. THE CIF REPLACED THE BLF AS THE PRIMARY SOURCE OF BOARD-APPROVED SPENDING FOR SUPPLEMENTAL DRAWS OR INVESTMENTS IN NEW INITIATIVES.
